

Status Updates: PY1 Reporting for Q-RU5

- Per PY1 Manual, DPH report 2 rates for Q-RU5:
 - Rate #1 for future P4P accountability:
 - Rx claim must have originated from a DPH provider Rx
 - Rate #2 for reporting only, no P4P accountability:
 - Not limited to Rx claims originating from a DPH provider Rx.
- DHCS PY1 Reporting Template lacked clear instruction on where/how to enter Rate #2 data.
- DHCS will ask DPH to confirm Rate #1 and Rate #2 data as part of DHCS' review of each system's QIP PY1 report



Status Updates: PY1 Payment

QIP payments are factored into Medi-Cal Managed Care rates and represent incentives the quality of services provided during a specific rate year, which follows the fiscal calendar (July to June)

- June 2019 Final approved data submitted to DHCS Capitated Rates
 Development Division for payment to DPH
 (pg 20, PY2-4 Pre-Print)
- July 2019 DPH put up IGT
- Sept 2019 DPH receive payment




Status Updates: PY2 Benchmarks

- All measures P4P with standard 10% gap closure methodology
 - Q-RU4 may be an exception
- DHCS released PY2 Version 5 on 1/22/19
 - SNI posted copy on <u>SNI Link / QIP /</u> <u>Reporting</u>

- Q-RU4 30 Day Unplanned Return to OR
 - Still pending
 - Finalization not assured

- Estimated release ~ Feb 2019 Mid –March 2019

Minimum Case Number-Clarifications

Same info as in Jan webinar

- A measure needs denominator ≥ 30 two years in a row in order to be eligible for payment the second year
- A measure reported on 12/15/2019 for PY2 but not reported on 12/15/18 for PY1, must also report statistically valid historical data from PY1 on 12/15/2019 in order to receive an achievement value for that measure.
 - Payment for achieving targets only
 - No payment given for reporting historical performance.
- A measure w/denominator <30 in PY1 and ≥30 in PY2</p>
 - May be reported in PY2, but no payment for that measure.
 - Can counts towards the requirement to report at least 20 measures for any payment
- DPH have until 12/15/19 to decide which measures to report on in PY2 (per DHCS: independent of PY1 measure selection)



Minimum Managed Care lives in Denominator

Effective PY2, DHCS to require that each measure have a minimum denominator size of ≥30 and a minimum of 1 Medi-Cal Managed Care life to be eligible for payment

SHARING SUPPLEMENTAL DATA WITH MANAGED CARE PLANS






Context

- 2018: CAPH/SNI co-hosted 2 meetings for DPH & Plan partners on improving data exchange & encounter data integrity (materials on <u>SNI</u> <u>Link</u>)
- Q1 2019: QIP Quality Advisory Group (QQAG) re-forming with MCP HEDIS experts
 - Planning team: DHCS Office of the Medical Director/Managed Care, SNI,
 CA Assoc. of Health Plans (CAHP), Local Health Plans of CA (LHPC)
 - Bidirectional data sharing
 - Updating MCP value sets for DPH QIP reporting (PY1 missed a few value sets)
 - DPH submission of supplemental data for MCP HEDIS reporting
 - Early 2019: DHCS heard concerns from Plans about some DPHs making data sharing with Plans a "low priority"



 - Some PHS are under minimum performance thresholds




