Updates

QPL 21-005 released via DHCS listserve 8/6

- Q-LBP, Q-URI, Q-AAB, Q-PCE: Numerator compliance and denominator inclusion should be calculated using data only from services and encounters that occurred at the QIP entity's own facilities. Non-QIP entity data should be excluded from these measures.
- **Q-FUA:** Denominators should be calculated using data only from encounters that occurred at the QIP entity's own facilities (exclude non-QIP entity encounters). However, non-entity encounters and services can be included when calculating the numerator.
- Q-TRC: contains two errors related to bullet formatting and inclusion.
- Q-CCW Women who are not sexually active or who do not have male partners must be included in the denominator. PY4 spec does not permit excluding.

Correction: Prior version Q-CMS138 Tobacco denominator column said "only reporting on Rate #3". It now reads "QIP PY4 to report on all 3 rates."

ECDS Specs

- Reminder: For PY4, QIP entities must use the ECDS spec for DRR.
 - Page 193: "Note: The measure description provided below is for reference only and is not the full measure specification. To report this measure, refer to the digital measure package available for purchase in the NCQA Store for the complete HEDIS digital measure specification. QIP entities are accountable for all potential updates included in the digital measure package."
 - Read through Appendix 6 of the PY4 Manual.
- PY5 digital bundle will have ECDS specs for DRR & PRE (new measure), available ~ Dec 2021.
- Over time, NCQA is moving towards ECDS only measures.
